

Trolls World Tour Movie Night Terms and Conditions

1. The "Trolls World Tour Movie Night" promotion commences at 11.00am (AEDT) on Monday 24th February 2020 and closes at 3.00pm on Friday 20th March 2020 (AEDT) ("Promotional Period").
2. Information on how to enter and prizes form part of these Conditions of Entry. All applicable laws and regulations apply.
3. In order to participate in the promotion, persons must be a financial member of Wentworthville Leagues Club. Persons suspended or excluded from the venue are not eligible to enter or participate in the promotion.
4. Provisional members are eligible to enter the promotion and claim prizes; however, prizes will not be distributed until full membership has been approved.
5. Those not eligible to enter the promotion include the following persons listed below and their immediate family of any of them (including a spouse, de facto partner, child, brother or sister) -
 - a. Club directors
 - b. Club auditors
 - c. Club employees
 - d. Officers, executive or any other staff of supplier or contractors to the club
 - e. People whose usual place of work is within premises owned or leased by the club who are employed by any of the contractors, licensees or lessees for the club.

Entry Requirements

6. Entry tickets are issued by purchasing one (1) cup of any available flavour of gelato at Crave Desserts.
7. Entry tickets are not limited but will be issued per menu item meaning that a member will receive one (1) entry ticket every time he/she purchases one (1) cup of gelato at Crave Desserts during the promotional period.
8. An entry box will be located on the counter at Crave Desserts. To enter into the draw the entry ticket must be placed into the entry box located at Crave Desserts.
9. Prizes will be drawn every Friday at 3.00pm during the promotional period, with the final draw taking place on Friday 20th March 2020.

Prize and Draw Details

10. Each prize winner will receive 1 x Family Pass (4 x general admission passes) to an exclusive VIP VMAX Red Carpet Screening of Trolls World Tour, held on Monday the 23rd of March 2020 at Events Cinemas Castle Hill, Castle Towers. The event will commence at 6pm and will conclude at 8.30pm. Tickets include VMAX seating and a snack pack to enjoy during the movie. Please note that children must be accompanied by an adult meaning that at least one (1) of the four (4) general admission tickets must be for an adult.
11. Each winner can only win once, if he/she is drawn a second time throughout the promotion period a redraw will take place.
12. Each draw will be conducted by a member of the Marketing Department and will be drawn at 3.00pm on Fridays during the promotional period.
13. The prize winner does not need to be present at the time of the draw.
14. The winner will be contacted over the phone by a member of the Marketing Department. If the winner cannot be contacted over the phone he/she will be contacted via email.
15. Each winner will acknowledge receiving their movie tickets by signing the "Prize Register Pick Up Sheet". This "Prize Register Pick Up Sheet" is to be returned to the Marketing Department.
16. There is a total of twenty-four (24) prizes and four (4) draw dates. Four (4) general admission tickets will be reserved for representatives of Wentworthville leagues Club.

18. Persons found to be swiping membership cards on behalf of other members will result in both parties being disqualified and ineligible to win prizes, even if this is not discovered until after the draw date.

21. If for any reason the Promotion is not capable of running as planned for reasons beyond the control of the Promoter, the Promoter reserves the right in its sole discretion to cancel, terminate, modify or suspend the promotion, subject to state regulations.
22. By entering, you acknowledge and agree that you have read, consented to and complied with, and will be bound by, these Conditions of Entry. You further agree that the decisions of the Promoter will be final and binding in all matters relating to the Promotion. The Promoter and its directors, employees, representatives and agents shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for personal injury which is suffered or sustained, as a result of accepting or using any of the prizes, except for any liability which cannot be excluded by law. To the extent permitted at law, you release and discharge the Promoter and its directors, employees, representatives and agents from any and all actions, claims, proceedings, damages, costs and expenses arising out of or in connection with the Promotion and/or the prizes.
